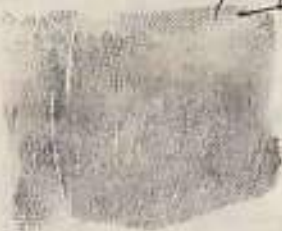

- To do all such things and perform all such acts as may be necessary or proper for the achievement of any or all of the above objects.

All the activities of the Trust shall be charitable and without any profit motive.

(B) In furtherance of the above objects, the Trust may ;

- Purchase or acquire lands and buildings and rebuild, renovate, remodel, preserve and maintain them.
- Sale land and/or building already acquired and to purchase other suitable sites in their place if and when so deemed expedient .
- Purchase , take in lease or in exchange or otherwise acquire any movable or immovable properties and construct and maintain such building and to do all acts and deeds which may be expedient or necessary for the said purpose.
- Co Operate or Collaborate with other institution, funds or trust, with objects similar to those of trust.
- Take over or to join hands and manage other Trust, institution etc. with objects similar to those and the trust.
- In the event of any of the first or subsequent trustees ceasing to be a trustee by reasons of death, resignation or any other reason, the board of trustee have every right to appoint new trustees and to allocate areas of operation for him/her.
- In the event of any of the trustees undertaking which are not in consonance with the objectives of the trust and/or is against the interest of the trust and/or is illegal , immoral in eyes of law, the board of trustees have the power to remove form the office of the trustees.

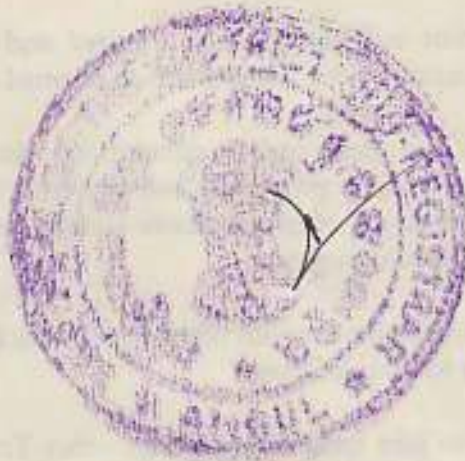

8. Should at any time the trustees fail to agree in the matter of appointment of the trustees, the matter shall be referred to the court of the district Judge which selection shall be final and binding.
9. A trustee shall cease to be a trustee in the following events :
 - a) If he/she resigns.
 - b) If he/she become insane or unsound mind
 - c) If he/she is adjudged an insolvent.
10. The Board of Trustee shall hold and possess the properties comprised these presents and any further accretions or acquisitions for the benefit and furtherance of the several public beneficial objects describe herein before .
11. Save expressly prohibited herein above where the board of trustees shall have all the powers to deal with the properties of trust and to receive donation contribution in whatever form from within and outside India and spent money for the benefits of the trust and its objects and to invest money in Govt securities, shares, debentures or other stocks or with Banks or Banking firms or other parties of sound financial credit, including any firm or firms wherein any one or more of the trustee may be partner or otherwise interested. The board of trustees shall have power and discretion to lease out the trust properties in suitable terms and to acquire for the trust, property under lease , licenses or by way of mortgage , sale or exchange . They shall also have power to vary and ulter or renew investments or so as to secure better interest yield.
12. Engage or employ persons or grant contract for carrying out of one or more of its activities.
13. Open and operate Bank accounts, raise funds either on loan or by subscription contribution and donation and

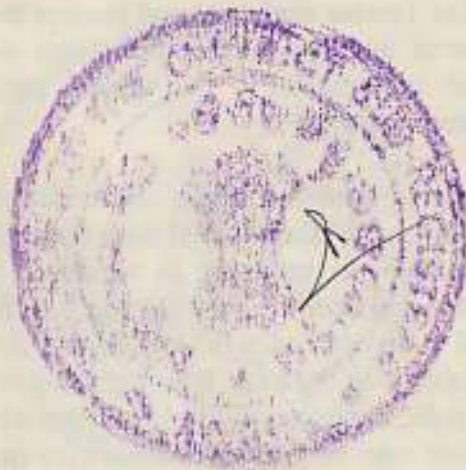

- (G) The board trustees shall not at any time sell, mortgage or otherwise encumber any of the immovable properties of the Trust unless such sale, alienation or encumbrances is in the interest of the Trust and its object and agreed upon by majority trustees of the board of trustees.
- (H) The decisions of majority of trustees at any meeting of the board of trustees shall be the decisions of the board of trustees and shall be given effect to unless inconsistent with the object of the trust or the directions laid therein.

The board of trustees shall cause to be maintained regular and accurate accounts of all the assets of the trust and its income and expenditure. All such accounts shall be made up annually and shall be duly audited by a firm of chartered accountants every year.
